We have a **Blockchain-Research Interest Group (B-RIG)** a closed group initiative by our center from 2022 working towards to educating the young minds about the Distributed Ledger Technology (DLT) and contribution through research. In addition, we have **Kerala Blockchain Academy Innovation Club (KBAIC)** at our university, in the two completed cohorts around 60 students have completed Certified Blockchain Associate (CBA) program, and selected students have completed further level of certifications including **Certified Ethereum Developer (CED)** and **Certified Hyperledger Fabric Developer (CHFD)**.
