- Hyperledger Transact provides an extensible approach to implementing new smart contract languages called "smart contract engines." Each smart contract engine implements a virtual machine or interpreter that processes smart contracts. Examples include Seth, which processes Ethereum Virtual Machine (EVM) smart contracts, and Sabre, which handles WebAssembly smart contracts
